Re: Request for Expedited Subpoena of Yahoo, Inc.

Defendant, Teresa Stephens, in the above case is requesting from the Court a subpoena to preserve evidence of email account of butterfly75218@yahoo.com. On Monday, August 4 someone illegally and deliberately entered my Yahoo Email Account and deleted all emails/chat conversations regarding this case. Yahoo initially told me they were able to retrieve my old mailbox; Yahoo then changed to a subpoena would be required to retrieve all lost evidence [Exhibit A]. Defendant feels that these emails are extremely important to the Discovery in this case. Plaintiff's Attorneys have already requested a forensic examination of the computer that was tampered with in a Bank of America safe deposit box [Exhibit B] and a request for production is on its way. Defendant will be unable to comply with any requests for discovery unless a subpoena is issued.


